Special Awards

Club Person of the Year

A person who works for the benefit of the Club, dedicated to 'helping' with various activities for the benefit of the sport. They work tirelessly without the expectation of recognition, often the 'unsung hero'. This person does not have to be an office holder or have any specific job. No minimum years of service are required to attain this award.

Junior Club Person of the Year

A person aged between 5 and 17, who works for the benefit of the Club, dedicated to 'helping' with various activities for the benefit of the sport. They work tirelessly without the expectation of recognition, often the 'unsung hero'. No minimum years of service are required to attain this award.

Manager of the Year

The nominee must be an active manager who fulfils their responsibilities competently and professionally. They are reliable and efficient. Work done is for the benefit of the club or association. Consideration will also be given for efforts made to attend meetings. Minimum of two years service in a managing role (does not necessarily have to be concurrently) must be attained before a person can be considered for the award.

Coach of the Year

The nominee must be an active coach either within the club, association or at a national level. The coach should install enjoyment of the game in the players regardless of the results

The results achieved by the players coached will be taken into consideration. The nominee has a professional approach to all their coaching and is respected by players and other coaches. Ideally the nominee should show efforts to further develop their coaching skills and knowledge by attending one or more coach education courses. Minimum of two years service in a coaching role (does not necessarily have to be concurrently) must be attained before a

person can be considered for the award.

Long Service Awards

The nominee has shown outstanding commitment to the Club. This award can be achieved by both players, coaches, managers and officials. The award will be given at 10years, 15years and 20years of service.
